

COSCO SHIPPING Ports Limited Container Throughput in March 2025

HIGHLIGHTS

March 2025 throughput

- Total throughput (excluding QPI and CTT) continued to maintain growth momentum in March, rising by 7.1% YoY. As for throughput in China, terminals in the Pearl River Delta and Southwest regions performed particularly well. Overseas terminals continued to grow, with their throughput increasing by 4.0% YoY, among them, CSP Spain and CSP Zeebrugge terminals performed relatively well, with throughput increasing 5.0% and 13.9% YoY, respectively.

- Non-subsidiaries (excluding QPI and CTT) +8.7% Y/Y
- China portfolio (excluding QPI) +8.5% Y/Y
- Overseas portfolio (excluding CTT) +4.0% Y/Y

2025 YTD throughput

- For the first quarter, CSPL recorded a 7.6% YoY increase in total throughput (excluding QPI and CTT).
- Subsidiaries +7.2% Y/Y
- Non-subsidiaries (excluding QPI and CTT) +7.8% Y/Y
- China portfolio (excluding QPI) +8.0% Y/Y
- Overseas portfolio (excluding CTT) +6.9% Y/Y
