Container Throughput in June 2025

HIGHLIGHTS

June 2025 throughput

- Total throughput (excluding QPI and CTT) continued to maintain growth momentum in June, rising by 4.6% YoY. As for throughput in China, terminals in the Southwest and Pearl River Delta regions performed well. Overseas terminals continued to grow, with their throughput increasing by 10.1% YoY, among them, CSP Zeebrugge Terminal had a very strong performance, with throughput increasing by 47.9% YoY.

- Non-subsidiaries (excluding QPI and CTT) +6.7% Y/Y
- China portfolio (excluding QPI) +2.4% Y/Y
- Overseas portfolio (excluding CTT) +10.1% Y/Y

- For the first 6 months of 2025, CSPL recorded a 6.0% YoY increase in total throughput (excluding QPI and CTT).

- Overseas portfolio (excluding CTT) +8.4% Y/Y
